Shipments require specific equipment, storage facilities, harmonized handling procedures and above all, strong cooperation among the cold chain partners.

In this 1-hour session, we will hear about the delivery of Sotrovimab, a breakthrough monoclonal antibody (MAB) treatment for patients diagnosed with Covid-19.

Through an extraordinary collaboration among many partners and across many time zones, Abu Dhabi was the first in the world to receive Sotrovimab. The first patient was infused within hours of plane wheels touching ground at Abu Dhabi International Airport. The session will begin with a 1-minute video from Etihad Airways.
